## Section II – Articles of Agreement

### Section III – Schedule of Prices

Company agrees to pay Contractor in accordance with the pricing as detailed in Appendix 3 - Schedule of Prices, as per **CONTRACT SIPD-573** in consideration of the Civil & Structural Works in accordance with the Contract.

The limiting, but not guaranteed Price (not-to-exceed value) for this Contract is **United States Dollars Five Hundred Fifty Thousand Only (USD 550,000.00 only)**. The rates and prices contained herein shall be fixed for the duration of the Contract and are deemed to be inclusive of applicable Withholding Tax, which will be deducted by the Company from each invoice that is submitted by the Contractor.

The rates and prices are inclusive but not limited to the procurement and delivery of all materials, labour, tools and equipments, consumables, supervision, PPE, accommodation, feeding, equipment, office/head office support and all other costs including overtime, holiday allowance, travel time, cost of transportation/mobilization, boarding and lodging, overhead, profit, insurances, taxes etc. The rates are not subjected to fluctuation or variation. Mobilisation and execution of the said work in this Contract shall be based on Company's instructions and relevant approvals.

### Section IV – Description of the Works (the term Goods, Work or Services shall have the same meaning)

Contractor shall undertake all works as detailed within Appendix 4 - Scope of Work in conjunction with the specifications outlined in SIPD 573.

Work shall commence with effect from **07<sup>th</sup> July 2013** and all works are to be completed within 3 months of commencement date.

Contractor shall be fully responsible for securing all necessary gate passes and permits required for the performance of the Work. Contractor is referred to Appendix 5.

### Section V – Administration Instructions

#### General

Any notice, by either party, to the other concerning the Contract shall be to Company and Contractor addresses specified below. In the event of a change of address of Company or Contractor, prompt notice shall be given by the party concerned to the other party.

#### Invoicing

- 1.1 Only Original invoices, which are properly prepared and supported and submitted to the COMPANY in the English language at the location specified herein, shall be processed for payment. Copies of invoices are not required unless specifically requested by the COMPANY. Appendix 2 shall be returned to COMPANY within 5 days after issue date of this Contract/Order.
- 1.2 The invoice shall be submitted in a single currency and must be in the same currency in which CONTRACT/ORDER is issued. Any reimbursable expenses incurred in a local currency, if applicable, shall be invoiced separately and the exchange rate used shall be that of the date of local currency invoice using the commercial bank exchange rate or the country exchange rate, as appropriate, received by CONTRACTOR when disbursing such local currency payments from the initial currency of the CONTRACT/ORDER.
- 1.3 The date of receipt of Invoice by the COMPANY'S Accounts Payable shall be used as the basis for calculating the due date for payment.

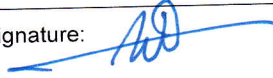
Invoice shall be sent to the company via post or courier to the above address.

- 1.4 Invoices shall be raised by the CONTRACTOR once each month for all the work/services performed or goods delivered in the previous calendar month or as agreed according to CONTRACT/ORDER and shall be submitted to the COMPANY prior to the tenth (10) working day of the month following the calendar month for which the invoices are raised or the goods have been delivered or services and work have been performed.
- 1.5 The CONTRACTOR shall attach to all its invoices proper supporting documentation (as applicable), to include but not be limited to approved original timesheets or work appraisal sheet, third party invoices, local payrolls, value of LOCAL CONTENT applicable, broken down according to defined Work Breakdown Structure (WBS), Variations, Milestone Completion Certificates etc, which support the value of each item on the invoice.
- 1.6 Each of the CONTRACTOR'S invoices shall clearly state the following:
- The invoicing address as mentioned in clause 1.3 above;
  - The COMPANY Contract title, number and Work Breakdown Structure (WBS) Code as specified in the order;
  - The description of the services supplied;
  - The Invoice date;
  - The Name of COMPANY REPRESENTATIVE as specified in the CONTRACT;
  - The invoice currencies
  - The bank details as indicated in Appendix 2;
- 1.7 The CONTRACTOR shall present all invoices in its registered name specified in Section I – FORM OF AGREEMENT.
- 1.8 The COMPANY shall authorize payment of the due amount within the payment terms into the bank account of the CONTRACTOR as specified by Contractor in Appendix 2.

If the information required in article 1.6 is not provided or is incorrect and/or the information required in Appendix 2 is not provided, the invoice may be returned for completion of information and payment may therefore be delayed. The COMPANY shall make no payment until the CONTRACTOR has fulfilled all the requirements of this Article. The CONTRACTOR understands and accepts that any failure on its part to comply completely with the requirements of this Article may delay payment of its invoices.
